### **Correspondence:**

• Chief Hartsock reports that the Chicken Festival requested a F class permit and with that there is road closure for July 13, 2018 at 5:00 p.m. until July 15<sup>th</sup> at 1:00 a.m. This will take place on Panther Pride Drive from Taylor Street to the dead end like previous years. • Delta Public Library – Certificate of Recognition

# Old Business:

**Resolution #18-06:** To renew an existing tax levy for recreational purposes A motion was made by Todd, seconded by Thomas to declare it necessary to renew an existing tax levy for recreational purposes pursuant to Ohio Revised Code sections 5705.19(H) and 5705.25 and requesting the auditor to certify the amount of revenue to be generated by the proposed levy renewal on its 3rd reading. **Ordinance #18-08:** Establishing the municipal electric utility department A motion was made by Wilton, seconded by Todd to establish the municipal electric utility department to serve electric customers within the Village of Delta on its 3rd reading. All votes yea, motion carried.

**Ordinance #18-09:** To dispose of certain surplus property not needed for municipal purposes.

A motion was made by Thomas, seconded by Wilton to authorize the Village Administrator to dispose of certain surplus property not needed for any municipal purpose on its 2nd reading. All votes yea, motion carried.

### New Business:

**Ordinance #18-10:** To contract with Poggemeyer Design Group for storage complex

A motion was made by Wilton, seconded by Thomas to authorize the Village Administrator to execute a contract amendment with Poggemeyer Design Group for design and bidding of storage complex for the wastewater treatment facility needed as part of the CSO project financed by USDA on its 1<sup>st</sup> reading. All votes yea, motion carried.

**Ordinance #18-11:** Supplement Ordinance #17-38 for the current expenses A motion was made by Thomas, seconded by Frank to supplement Ordinance #17-38 to make supplemental appropriations for the current expenses of the Village of Delta for the fiscal year ending December 31, 2018 on its 1<sup>st</sup> reading. All votes yea, motion carried.

**Resolution #18-08:** To participate with Fulton Co Engineer for bidding road salt A motion was made by Frank, seconded by Todd to authorize the Village Administrator to participate with the Fulton County Engineer for bidding and purchase of road salt for the 2018-2019 season on its 1<sup>st</sup> reading. All votes yea, motion carried.

A motion was made by Frank, seconded by Wilton to approve the invoices in the amount of \$145,693.08. All votes yea, motion carried.
