## Minutes January 20, 2020:

A motion was made by Frank Wilton, seconded by Lynn Frank to approve the January 20, 2020 council minutes. All votes yea, motion carried.

## **Visitors:**

#### Rules & Ordinance:

• Report of committee meeting regarding draft Ordinance #20-02

Ashley Todd states there was a committee meeting earlier this evening to discuss Ordinance #20-02. She announced that the committee made a recommendation to submit legislation at the next council meeting.

#### **Old Business:**

**Ordinance #20-01:** Accepting petitioned land for annexation A motion was made by Wilton, seconded by Todd to accept petitioned property for annexation filed with the Village of Delta and establish the zoning classification for the same on its 3rd reading. All votes yea, motion carried.

Johnson asked about the zoning which is M-2

**Resolution #20-01:** An agreement with Feller Finch & Assoc

A motion was made by Wilton, seconded by Todd to authorize the Village

Administrator to execute an agreement with Feller Finch & Associates for land plan and concept work and professional services to facilitate residential growth in Delta on its 3rd reading. All votes yea, motion carried.

<u>Ordinance 20-03:</u> To secure loan/grant with the USDA

A motion was made by Todd, seconded by Frank to authorize the Village

Administrator to make application for and execute any necessary documents to secure loan/grant finance package with the USDA of Rural Development for the reconstruction of a portion of Fernwood Street infrastructure on its 2nd reading. All votes yea, motion carried.

#### **New Business:**

**Resolution #20-03:** Relinquishing the title & interest to a deed restriction

A motion was made by Todd, seconded by Wilton to relinquish the title and interest to a deed restriction and authority to regulate parking pertaining to certain real property for purpose of sale on its  $1^{\rm st}$  reading. All votes yea, motion carried.

A motion was made by Frank, seconded by Johnson to approve the invoices in the amount of \$163,407.64. All votes yea, motion carried.

# Questions related to council proceedings:

Thom Gorman, 202 Adrian Street, questioned if the work that was done on Maplewood Street is complete.

Mr. Peebles explained that the storm line has been installed and a sewer line has been repaired. Once the weather breaks restoration will be completed.
