A motion was made by Tony Dawson, seconded by Frank Wilton to approve the October 19, 2020 council minutes as written. All votes yea, motion carried.

Mayor Gilbert swore in Chase Hensley (Police Officer) at this time.

Correspondence:

 Lynn Frank reports to council she received a letter from Swanton pertaining to the EMS and Fire service uncertainty meeting for the surrounding municipalities.

Administrator Report:

- Written report was submitted to council
- Announced that demolition of the old water plant is scheduled for tomorrow, November 3, 2020

• Delta has submitted a letter of interest to ODOT for the potential extension of the NORDA bike path into town.

Mr. Dawson asked the Administrator about the pole on Main and Madison Street. Mr. Peebles reports it was supposed to be started by the end of October.

Mr. Johnson states he was approached by a resident concerning the area on Adrian Street that was dug up for a water leak last week. Mr. Peebles explained that it was patched today and is intended to be ground out next year and repayed since it is rough.

Finance Director Report:

• Reports there was 40 accounts that signed up for ACH and will receive the \$25.00 credit on their water bills and is part of the CaresAct grant.

Old Business:

Ordinance #20-26: To increase sanitary rates charged for sewer A motion was made by Wilton, seconded by Frank to increase sanitary rates charged for sanitary sewer for the Village of Delta on its 3rd reading. All votes yea, motion carried.

A motion was made by Dawson, seconded by Wilton to establish a panel of individuals to serve in the capacity of contingency plan evaluations and drinking water source plan review for the water treatment operations of the Village on its 2nd reading. All votes yea, motion carried.

Ordinance #20-30: To make appropriations for the year 2021 A motion was made by Wilton, seconded by Frank to make appropriations for the Village of Delta, Ohio for the year 2021 on its 1st reading. All votes yea, motion carried.

Ordinance #20-31: Establishing salaries & wages for employees A motion was made by Todd, seconded by Wilton to establish salaries and wages for employees of the Village of Delta, Ohio on its 1st reading. All votes yea, motion carried.

Ordinance #20-32: Authorizing to dispose of certain surplus property

A motion was made by Wilton, seconded by Todd to authorize the Village Administrator to dispose of certain surplus property not needed for any municipal purpose on its 1^{st} reading. All votes yea, motion carried.
