A motion was made by Lynn Frank, seconded by Tony Dawson to amend the agenda to take Swearing in Police Officer Jared Wood off the agenda. All votes yea, motion carried.

## **Approval of Minutes: Council September 20, 2021**

A motion was made by Tony Dawson, seconded by Lynn Frank to approve the September 20, 2021, council minutes as written. Dawson — Yea, Johnson — Yea, Tanner — Abstain, Frank — Yea, Thomas — Yea. Motion carried.

Mr. Peebles explained to council what was done on Pelton Drive to help eliminate the flooding issues.

Mrs. Donaldson, 2 Pelton Drive, stated they did have someone camera under the house and drainage tiles, and they didn't find any blockage. There is a question of what is under the house, as there is a hole in the floor and is the only place that sewage may have come up through. She said they are still working on it.

A motion was made by Frank, seconded by Tanner to establish a new fund (Grant Construction Fund) consistent with the requirements of O.R.C. 5705.09(f) and declaring an emergency. All votes yea, motion carried.

**Resolution #21-17:** Declaring it necessary to levy a tax A motion was made by Dawson, seconded by Frank to declare it necessary to levy a tax in excess of the ten (10) mill limitation on its 2nd reading. All votes yea, motion carried.

**Resolution #21-18:** Authorize execution of agreements with Certified Oil Company

A motion was made by Tanner, seconded by Frank to authorize the Village Administrator to execute agreements with Certified Oil Company for the purchase of property located at 200 Main Street on its 2nd reading. Dawson – No, Johnson – Yea, Tanner – Yea, Frank – Yea, Thomas – Yea. Motion carried.

**Resolution #21-19:** Apportionment of local government funds
A motion was made by Frank, seconded by Dawson to suspend the readings for Resolution 21-19. All votes yea, motion carried.

A motion was made by Mike Tanner, seconded by Chad Johnson to enter into an executive session to discuss pending or eminent legal actions involving the Village of Delta. All votes yea, motion carried.

A motion was made by Lynn Frank, seconded by Tony Dawson to exit the executive session at 5:56 p.m. All votes yea, motion carried.

A motion was made by Tony Dawson, seconded by Mike Tanner to enter into an executive session to discuss personnel matters. All votes yea, motion carried.

A motion was made by Tony Dawson, seconded by Lynn Frank to exit the executive session at 6:20 p.m. All votes yea, motion carried.
