Mr. Peebles reports that it looks like this project may start this year yet. There is just a lot of red tape USDA requires.

• Discuss changing FEMA requirements for discounted flood insurance

Mr. Peebles explained Delta has been working on the renewal for FEMA floodplain classification, which Delta is currently under a Class 9 prerequisite. He explains that FEMA has changed their standards to be more stringent standards. He explained some issues, and mandates that will affect Delta.
