#### Approval of Minutes: Council April 18, 2022

A motion was made by Tony Dawson, seconded by Chad Johnson to approve the April 18, 2022, council minutes as written. All votes yea, motion carried.

#### **Public addressing council:**

Ernie Wells, 409 Parkwood Avenue, has been battling the speeding vehicles on the street. He states there is a 10-mph sign posted but no one abides by it and Chief Hartsock told him he could not enforce the speed limit at 10 mph. Mr. Wells would like to see a speed limit sign that the police department can enforce and see the cars slow down.

Chief Hartsock states he has discussed this issue with Mr. Wells and agrees that a 25-mph speed limit sign would help so they can enforce the speed.
