# Old Business:

**Ordinance #22-13:** Execute required documents to sell rights of an easement

# New Business:

**Ordinance #22-14:** Amending the boundaries of the CRA A motion was made by Johnson, seconded by Dawson to amend the boundaries of the community reinvestment area established in 1992 for the Village of Delta on its 1<sup>st</sup> reading. All votes yea, motion carried.

Mr. Peebles explained the legislation and that this will be the third and final amendment and anything going forward from here, to be added to the CRA area, will be post 94.

**Resolution #22-11:** To establish the roadway dedication plan establishing Fox Drive

A motion was made by Ashley Todd, seconded by Chad Johnson to enter an executive session to discuss personnel matters for the Village of Delta. All votes yea, motion carried.

A motion was made by Tony Dawson, seconded by Mike Tanner to exit the executive session at 6:17 p.m. All votes yea, motion carried.
