**Resolution :23-01:** Indicating the Village will provide utilities to property seeking annexation.

A motion was made by Todd, seconded by Shirer to provide utilities and other services for the property seeking to be annexed to the Village with the filing of petition with the Fulton County Commissioners on its 2nd reading. All votes yea, motion carried.

# **New Business:**

**Resolution #23-02:** Establishing the Delta Park Board
