## **Finance Director:**

- Approval of invoices as presented.

### **Old Business:**

**Ordinance #23-10:** Declaring unpaid income tax amounts as uncollectable.

A motion was made by Frank, seconded by Dawson to declare unpaid income tax amounts as uncollectable and authorize the tax administrator to remove them from village accounts as a 3rd reading. All votes yea, motion carried.

#### **New Business:**

**Resolution #23-19:** To execute an amendment for Indigent Defense Services A motion was made by Dawson, seconded by Todd to authorize the Village Administrator to execute an amendment to the agreement for indigent defense services in Fulton County court proceedings on its 1st reading. All votes yea, motion carried.

**Resolution #23-20:** Agreeing to alternate plan of apportionment of Local Govt Funds

A motion was made by Todd, seconded by Shirer to read Resolution 23-20 for a 1<sup>st</sup> reading. All votes yea, motion carried.

A motion was made by Shirer, seconded by Todd to agree to alternate plan of apportionment of local government funds for the Village of Delta and declaring an emergency. All votes yea, motion carried.

**Resolution #23-21:** Accepting amounts and rates set by the Budget Commission A motion was made by Todd, seconded by Shirer to read Resolution 23-21 for a 1<sup>st</sup> reading. All votes yea, motion carried.

A motion was made by Todd, seconded by Shirer to accept the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the county auditor and declaring an emergency. All votes yea, motion carried.

Discussion regarding date and time for 2023 trick or treating in the Village of Delta Ashley Todd asked about having Halloween on Sunday rather than Tuesday, as the Delta Legion is having a Trunk or Treat event on Sunday and PDY schools are closed on Monday.

Mossing reminded the council that the Police Department is having Trunk or Treat on Tuesday, October 31<sup>st</sup>.

A motion was made by Chad Johnson, seconded by Robert Shirer to approve Trick or Treat on October 29, 2023, from 5:30 p.m. to 7:00 p.m. All votes yea, motion carried.
