



PARCEL 4 - 19.597 ACRES:

A parcel of land situated in the Northeast 1/4 of Section 12, T-7-N, R-7-E, York Township, Fulton County Ohio, and is more particularly described as follows:

Beginning at an iron pipe marking the Northeast corner of said Section 12; thence S 2°09'40" W along the East line of said Section 12 a distance of 1,326.87 feet to a point at the Southeast corner of the Northeast 1/4 of the Northeast 1/4 of said Section 12; thence N 89°47'47" W along the South line of the Northeast 1/4 of the Northeast 1/4 of said Section 12 (also the Corporation Line of the Village of Delta) a distance of 1,140.50 feet to a surveyor's stake at the Southeast corner of a parcel conveyed to Clement L. and Margaret Creager by Deed Vol. 126, Page 248; thence N 0°20'22" E a distance of 412.16 feet to an iron pin; said iron pin also being at the Northeast corner of a parcel conveyed to Kenneth and Alvah Woody by Deed Vol. 164, Page 177; said line is also the East line of parcels conveyed to Merlin A. and Pearl L. Tremain by Deed Vol. 142, Page 21; Emel A. Mizer by Deed Vol. 150, Page 150; Dale and Donna Jean Williams by Deed Vol. 150, Page 615; thence S 87°50'20" W along the North line of the above referred to Woody Parcel a distance of 383.43 feet to a P.K. nail on the centerline of County Road "7-2"; thence N 14°03'10" W along the centerline of County Road "7-2" a distance of 934.08 feet to a railroad spike at the intersection of the centerline of said road with the North line of said Section 12; thence N 89°30'20" E along the North line of said Section 12 a distance of 1,998.17 feet to an iron pipe marking the Northeast corner of said Section 12 and the PLACE OF BEGINNING; Subject to legal highways.



"7-2" and the North line of said Section 12; thence S 14°03'10" E along the centerline of Co. Rd. "7-2" a distance of 601.55 feet to a P.K. nail and the PLACE OF BEGINNING; thence N 87°31'20" E a distance of 298.38 feet to an iron pin; thence S 0°28'40" E a distance of 327.39 feet to an iron pin; thence S 87°30'20" W a distance of 220.18 feet to a P.K. nail on the centerline of Co. Rd. "7-2" a distance of 332.73 feet to a P.K. nail and the PLACE OF BEGINNING.
